AGREEMENT AMENDING AND SUPPLEMENTING AGREEMENT RECORDED IN 13816 P 488, OCR.

THIS AGREEMENT made this 22nd day of September A.D. 1960, by and between TROWBRIDGE FARMS COMPANY, a Michigan corporation, party of the first part, THE DETROIT EDISON COMPANY, a New York corporation, and MICHIGAN BELL TELEPHONE COMPANY, A Michigan corporation, parties of the second part, WITNESSETH AS FOLLOWS:

WHEREAS, the party of the first part holds title to Lot 66,

- 2. That the description appearing on the third page of said agreement as lines 19 to 21 inclusive, shall be amended to read as follows:

"From the northeasterly corner of Lot 60; thence southeasterly to a point in the southerly line of Lot 66, which point is 11 feet southeasterly along said lot line from its intersection with the easterly line of Canterbury Crescent."
