- 3) EDISON, its employes, agents and contractors shall have full right of ingress to and egress from the six (6') foot Right of Way referred to above for purposes of constructing, re-constructing, repairing, modifying, operating and maintaining its lines and equipment located either within said six (6') foot Right of Way or the conduit placed in the aforementioned building.
