Agreement, Made and entered into this 15th day of December

A. D. 1916, by and between E. P. McCarthey ^{married} Burroughs Village of Oakland County, Michigan, first part 1, and THE DETROIT EDISON COMPANY, a Corporation, second party.

WITNESSETH:

In consideration of the sum of One (\$1.00) dollar, receipt of which is hereby acknowledged, first part 1, for himself ~~his~~ heirs, executors, administrators and assigns, hereby grants unto said second party, its successors and assigns, the right, privilege and authority to construct, operate, and maintain, during the corporate existence of said second party, its lines for electric light and power, including the necessary poles, towers, wires, and fixtures upon, over, and across the property which he own, or in which he have an interest, in the Village of Burroughs, County of Oakland, and State of Michigan, the route of said line being as follows: Poles to be set in the rear of lots on the west side of Purdy St

Second party shall have the right to permit the attachment of the wires of any other company, and shall have the right to trim any trees along said lines so as to keep the wires clear at least Four (4) feet, to erect and set the necessary guy and brace poles and anchors, and to attach thereto the necessary guy wires.

Second party agrees to reimburse said first part 1 ~~of~~ his heirs and assigns, for all damages to his growing crops, buildings or fences, caused by its men and teams in entering said property from time to time for the purposes set forth herein.

IN WITNESS WHEREOF, first part 1 hereunto set his hand and seal, and second party has caused these presents to be executed the day and year first above written.
