Agreement. Made and entered into this 15th day of December

A. D. 1916, by and between Mrs G. J. Warner Birmingham
Village of Oakland County, Michigan, first part y, and THE DETROIT EDISON
COMPANY, a Corporation, second party.

WITNESSETH:

In consideration of the sum of One (\$1.00) dollar, receipt of which is hereby acknowledged, first part y, for
herself her heirs, executors, administrators and assigns, hereby grants unto said second party, its suc-
cessors and assigns, the right, privilege and authority to construct, operate, and maintain, during the corporate exist-
ence of said second party, its lines for electric light and power, including the necessary poles, towers, wires, and fix-
tures upon, over, and across the property which she own, or in which she have an interest, in
the Village of Birmingham, County of Oakland, and
State of Michigan, the route of said line being as follows: Poles to be set in the rear
of lot one the west side of Perry St

Second party shall have the right to permit the attachment of the wires of any other company, and shall have
the right to trim any trees along said lines so as to keep the wires clear at least Four (4) feet, to erect and set the
necessary guy and brace poles and anchors, and to attach thereto the necessary guy wires.

Second party agrees to reimburse said first part y her heirs and assigns, for all damages to
her growing crops, buildings or fences, caused by its men and teams in entering said property from time to
time for the purposes set forth herein.
