IN CONSIDERATION of the sum of One Dollar (\$1.00) Dollars and other valuable considerations, receipt of which is hereby acknowledged. We hereby grant to THE DETROIT EDISON COMPANY, its successors and assigns, the right to construct, operate and maintain its underground lines for the transmission and distribution of electricity and Company communication facilities, including the necessary conduits, fixtures, cables, manholes and equipment, under and across our property located in the City of Clawson, County of Oakland State of Michigan, and described as follows:

The Westerly 47 feet of that part of the Northwest 1/4 of Section 33, T 2 N, R 11 E, beginning at the Northwest corner of said section thence E 420.02 feet, thence S 0°01'15" W 413.30 feet, thence S 87°34' W 420.37 feet, to W line of said Northwest 1/4, thence N 429.58 feet to beginning.

The route of the lines shall be as follows: In an Easterly and Westerly direction across said land approximately 425 feet South of the center line of Maple Road. Upon 90 days' written notice, the Companies at their own expense shall make such changes and alterations in the said lines as shall be necessary at the time to avoid interference with any improvements or buildings in course of erection on said property.

The Company shall reimburse US for all damage caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purposes set forth herein.
