County of Oakland State of Michigan, and described as follows:
STREET AND VILLAGE OR SECTION AND TOWNSHIP

Part of the Northeast 1/4 of the Northwest 1/4 of Section 30, T2N, R11E, beginning on the North section line distant West 528 feet from the North 1/4 Section corner, thence S. 0°50' W. 55 feet, thence W. 10 feet, thence N. to the N. section line, thence east along said North Section line to the point of beginning.
