The West 60 ft of the North 1/2 of the South 1/2 of the Northwest 1/4 of Section 32, T24N-R1E except the South 32 1/2 ft thereof.

The route of the lines shall be as follows: in a northerly and southerly direction across and under said land approximately 35 ft easterly of the centerline of Coolidge Highway so-called.

The Company shall reimburse us for all damage caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purposes set forth herein.
