IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, we hereby grant to THE DETROIT EDISON COMPANY, its successors and assigns, the right to construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary poles, fixtures, guys and guy stubs, wires and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their operation, upon, over and across our property located in the City of Clawson

STREET AND VILLAGE, OR SECTION AND TOWNSHIP
County of Oakland, State of Michigan, and described as follows:

Part of the SW 1/4 Section 33, T 2 N R 11 E, Beginning at a point distant N 1255.23 feet from SW Section Corner Thence N 70 feet Thence S 89° 28' E 428 feet, Thence S 70 feet, Thence N 89° 28' W 428 feet to beginning.

The route of the lines shall be as follows: In a northerly and southerly direction across said land along approximately 45 feet east of the center line of Crooks road.

The Company, its successors and assigns, shall reimburse us for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property from time to time for the purposes set forth herein. The rider attached and made a part hereof.
