STREET AND VILLAGE, OR SECTION AND TOWNSHIP
County of Oakland, State of Michigan, and described as follows:
The North 300 feet of the South 2100 feet of the West 1/2 of the Northwest 1/4 of Section 33,
T 2 N, R 11 E.

The route of the lines shall be as follows: In a Northerly and Southerly direction across said land along approximately 47 feet East of the center line of Crooks Road.

The Company, its successors and assigns, shall reimburse us for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property from time to time for the purposes set forth herein.
