THE WEST 50 FEET OF THE NORTH 300 FEET OF THE SOUTH 2400 FEET OF THE WEST 1/2 OF THE NORTHWEST 1/4 OF SECTION 33 TOWN 2 NORTH RANGE 11 EAST.

The route of the lines shall be as follows: IN A NORTH WESTERLY AND SOUTHEASTERLY DIRECTION FROM A POINT APPROX. 125 FEET SOUTH OF THE NORTH LINE AND 25 FEET EAST OF THE WEST LINE TO A POINT APPROX. 150 FEET SOUTH OF THE NORTH LINE AND APPROX. 46 FEET EAST OF THE WEST LINE.

The Company shall reimburse US for all damage caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purposes set forth herein.
