WE IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, hereby grant to THE DETROIT EDISON COMPANY, its successors and assigns, the right to construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary poles, fixtures, guys and guy stubs, wires and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their operation upon, over and across OUR property located in CITY OF TROY

County of OAKLAND State of Michigan, and described as follows:

THE SOUTH 10 FT OF THE EAST 35 FT OF THAT PART OF THE EAST 1/2 OF THE NORTHWEST 1/4 SECTION 27 TOWN 2 NORTH RANGE 11 EAST LYING WESTERLY OF CENTER LINE OF ROCHESTER RD. AND SOUTH OF THE FOLD SUBDIVISION (LIBER 58 PAGE 24) AND NORTH OF SUPERVISORS PLAT #10 (LIBER 46 PAGE 42)

The route of the lines shall be as follows: ANCHORS IN AN EASTERLY AND WESTERLY DIRECTION, ALONG AND ADJACENT TO THE SOUTH LINE.

The Company shall reimburse US for all damage to growing crops, buildings or fences, caused by its men, teams, trucks, other vehicles and equipment in entering said property for the purpose set forth herein.

ABOVE In addition to the above consideration, the Company shall pay US the sum of FIVE \$ NO/100 (\$5.00) Dollars for RIGHT OF WAY on said land, the same to be paid before any WIRES are erected.
