This is in reference to the replacement of a distribution line by a 40 KV installation upon premises in the City of Troy, County of Oakland and State of Michigan, described as:

> East 6 feet of the South 634.8 feet of the Southeast 1/4 of the Northeast 1/4 of Section 34, Town 2 North, Range 11 East.

I have been informed that the title to this property is in Clarence Boucher and Regina Boucher, his wife.

Mrs. Boucher was adjudicated a mental incompetent on October 15, 1953 and committed to the Pontiac State Hospital where she presently is.

I have been informed that Mr. Boucher executed the necessary right of way grant to The Detroit Edison Company giving it the right to install a 40 KV line upon the above described premises.

On November 5, 1957 the undersigned and Mr. Robert Boss of your department discussed the legal procedure necessary for obtaining the consent of the Estate of Mrs. Boucher to this right of way. Mr. Boucher indicated that Mrs. Boucher was seriously ill and was not expected to live very much longer and that he did not want to be involved in any procedure whatsoever in connection with her. For that reason, her signature has not been obtained.
