County of OAKLAND State of Michigan, and described as follows:  
LOTS 25 thru 27 INCL. OF THE BEAVER HEIGHTS SUBDIVISION  
being PART OF THE NORTHWEST 1/4 OF SECTION 27 TOWN 2  
NORTH RANGE 11 EAST AS RECORDED IN LIBER 23 ON PAGE 11
