EASEMENT GRANT

A strip of land 12 feet wide, the centerline of which commences at a point in the South line of Section 6, Town 2 North, Range 11 East, said South line also being the centerline of Square Lake Road (120 feet wide), which point is 253.5 feet easterly from the Southwest corner of said Section 6; thence northerly and parallel to the West line of said Section 6, a distance of 781 feet to a point.
