of "Big Beaver Poultry Farms" part of the Southwest 1/4 of Section 24, Town 2 North, Range 11 East as recorded in Liber 23 of Plats on Page 14 of Oakland County Records.

The route of the lines shall be as follows: In an easterly and westerly direction across said land along the north line thereof.
