operation upon, over and across Over property located in City of Troy  
STREET AND VILLAGE OR SECTION AND TOWNSHIP

County of Oakland State of Michigan, and described as follows:

The West 6 ft of property described as beginning at a point on the E. line of Section 24, T 2 N R 1 E Sec 14 and being 1980 7/16 N 10 13' 0" E of the S.E. corner of the NE 1/4 of the SE 1/4 of Section 24 - Over -

The route of the lines shall be as follows: In a Northerly and Southerly direction along the West line

The Company shall reimburse us for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purpose set forth herein.

In addition to the above consideration, the Company shall pay us the sum of FIVE \$ 00/100 (\$5.00) Dollars for each pole on said land, the same to be paid before any poles are erected.
