WE IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, hereby grant to THE DETROIT EDISON COMPANY, its successors and assigns, the right to construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary poles, fixtures, guys and guy stubs, wires and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their

operation upon, over and across over property located in City of Troy,
STREET AND VILLAGE OR SECTION AND TOWNSHIP

County of Oakland State of Michigan, and described as follows:

The westerly 50 feet of property described as beginning at a point on the E. line of Section 24, T2N, R11E, said point being 1485 feet N 10° 13' 00" E. of the SE corner of the NE 1/4 of the SE 1/4 of said Section 24 - OVER -

The route of the lines shall be as follows: in a northerly and southerly direction, along the West line

The Company shall reimburse no for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purpose set forth herein.

In addition to the above consideration, the Company shall pay no the sum of Fifty No/100 (\$5.00) Dollars for each pole on said land, the same to be paid before any poles are erected.
