

For good and valuable considerations, the right is hereby granted to THE DETROIT EDISON COMPANY, 2000 Second Avenue, Detroit, Michigan, and the MICHIGAN BELL TELEPHONE COMPANY, 1365 Cass Avenue, Detroit, Michigan, their licensees, lessees, successors and assigns, to construct aerial and/or underground line facilities for the purpose of providing electric service and communication service, including necessary poles, guys, anchors, conduits, wires, cables, manholes, transformers and equipment, in, under, upon, over and across the property located in the City of Troy, County of Oakland, State of Michigan, further described as follows:

The west six (6) feet of the east one hundred and three (103) feet of the north twenty-two (22) feet of the south fifty-five (55) feet of the following described property. A part of the E. 1/2 of the W. 1/2 of the S.E. 1/4 of Section 11, Town 2 North, Range 11 East, City of Troy, Oakland County, Michigan, more particularly described as beginning at a point on the East-West 1/4 Section line at a point that is S. 86 degrees 51'59" E. 665.8 feet from the center part of Section 11, thence S. 86 degrees 51'59" E. 651.9 feet, thence S. 2 degrees 59'36" W 2441.6 feet, thence N. 87 degrees 08' 40" W. 315.8 feet, thence N. 3 degrees 15' 38" E. 283.27 feet, thence N. 87 degrees 08' 40" W. 347.58 feet, thence N. 3 degrees 15' 38" E. 2161.83 feet to the point of beginning, with full right of ingress and egress upon the said premises to employes or appointees of the said grantees to construct, reconstruct, repair, operate and maintain said line facilities, and to trim or cut down any trees which, in the opinion of the grantees, at any time interfere or threaten to interfere with the construction and operation of said line facilities.
