We, the undersigned, petition THE DETROIT EDISON COMPANY to extend its electric lines to, or beyond, our lands to make electric supply available on said lands.

For and in consideration of said line extension upon the special terms and conditions, made by The Detroit Edison Company for the benefit of rural districts, and in consideration of the grants of the other parties hereto, we, the undersigned, represent that we are the owners of the interest indicated, in the property described above our respective names, which property includes the route of the proposed present extension, as described or sketched upon the reverse side hereof or upon a separate appendage to be a part hereof, and do hereby grant permission to THE DETROIT EDISON COMPANY, its successors and assigns, to construct, operate and maintain its lines for the transmission and distribution of electricity upon, over and across our property along said route, and beyond if the line is extended, including the necessary poles, conduits, fixtures, guys and guy stubs, wires and equipment, and including the right to it, or any of the undersigned, to trim or cut down any trees along said lines which might in the opinion of The Detroit Edison Company, its successors and assigns, in any way interfere with or be hazardous to the construction, operation or maintenance of said lines.
