IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, we hereby grant to THE DETROIT EDISON COMPANY, its successors and assigns, the right to construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary poles, fixtures, guys and guy stubs, wires and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their operation, upon, over and across our property located in

TOWNSHIP OF MILFORD

STREET AND VILLAGE, OR SECTION AND TOWNSHIP

County of OAKLAND, State of Michigan, and described as follows:
That part of the West Half of the West Half of Section 10, T2N, R7E, lying North of General Motors Road and South, West and North of the Mill Pond.

The route of the lines shall be as follows: In a Northwesterly and Southeasterly direction across said land as now staked by the Company from the SE corner thereof to a point on the W line approximately 40 rods N of the E and W Quarter line of Section 10.

~~This agreement renders null and void a certain similar agreement signed by F. S. Hubbell and Elizabeth B. Hubbell dated February 27, 1933 and that portion of a certain similar agreement signed by Frank H. Alfred and Maud B. Alfred dated December 23, 1931 covering land in Section 10.~~

The Company, its successors and assigns, shall reimburse us for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property from time to time for the purposes set forth herein.

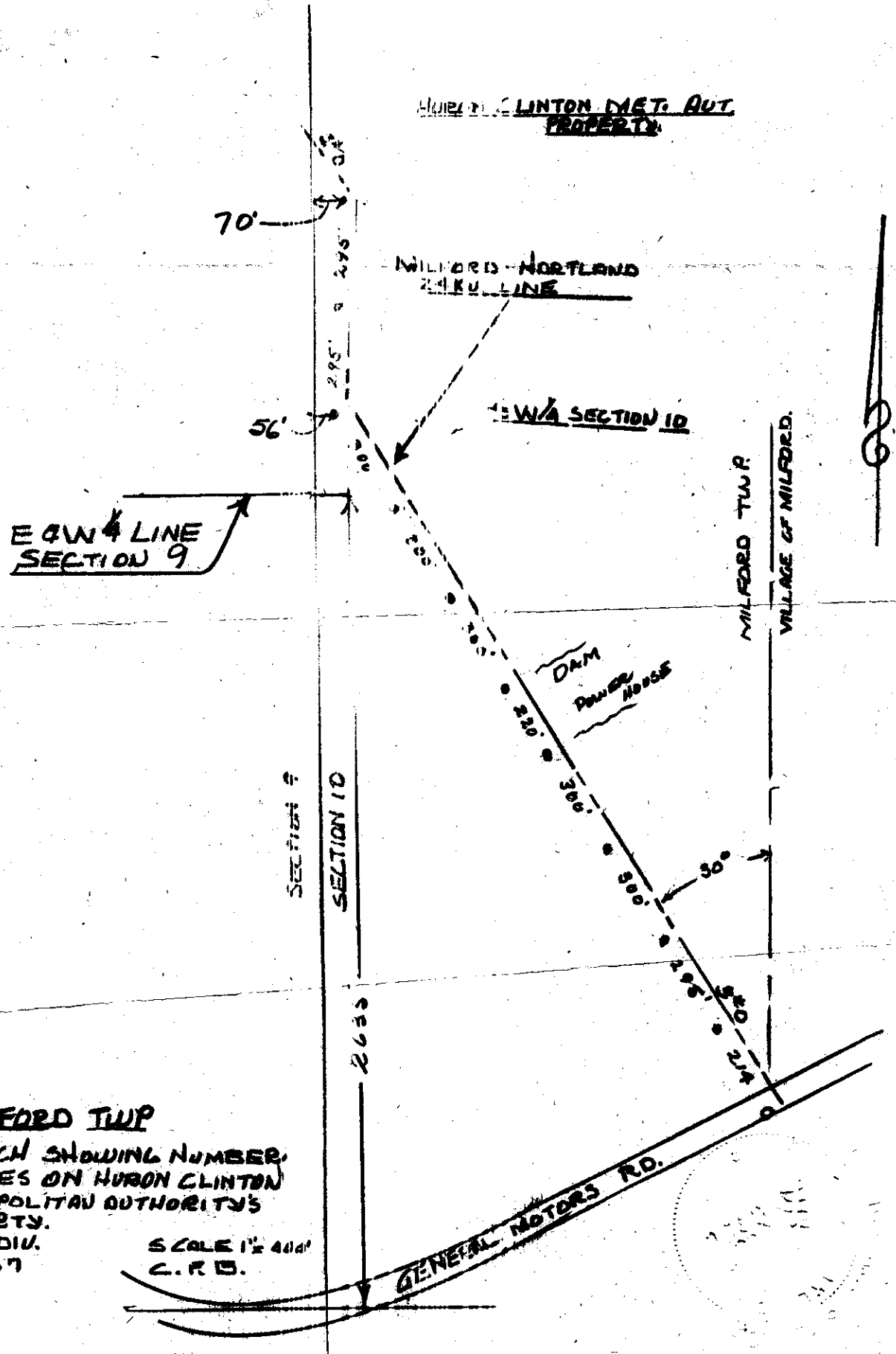
