County of OAKLAND State of Michigan, and described as follows:

THE WEST 60 FEET OF THE SOUTH 90 FEET OF THE SOUTH WEST 1/4 OF THE SOUTHWEST 1/4 OF SECTION 23 TOWN 2 NORTH RANGE 7 EAST
