WE IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, hereby grant to THE DETROIT EDISON COMPANY, its successors and assigns, the right to construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary poles, fixtures, guys and guy stubs, wires and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their

operation upon, over and across Out property located in VILLAGE OF MILFORD
STREET AND VILLAGE OR SECTION AND TOWNSHIP

County of OKLAHOMA State of Michigan, and described as follows:

THE SOUTH 60 FT OF THAT PART OF THE SOUTHEAST 1/4 OF THE SOUTHWEST 1/4 OF SECTION LOT IN R1E BEGINNING AT POINT DISTANT E 705 FT AND N 400 FT FROM SW CORNER, THENCE E 348.30 FT, THENCE NORTHERLY ALONG CENTER OF ^{NEW HUDSON} SAID RD 612.40 FT TO CENTER OF GENERAL MOTORS RD, THENCE SOUTHWESTERLY ALONG CENTER OF SAID RD 453.80 FT, THENCE SOUTH 437 FT TO BEG.

The route of the lines shall be as follows: ED IN EASTERLY AND WESTERLY DIRECTION ALONG AND ADJACENT TO THE SOUTH LINE THEREOF.

The Company shall reimburse me for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purpose set forth herein.

In addition to the above consideration, the Company shall pay me the sum of FIVE HUNDRED (\$500) Dollars for each pole on said land, the same to be paid before any poles are erected.

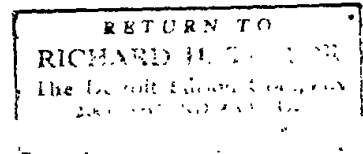
