we **IN CONSIDERATION** of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, we hereby grant to **THE DETROIT EDISON COMPANY**, its successors and assigns, the right to construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary poles, fixtures, guys and guy stubs, wires and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their operation, upon, over and across our property located in Township of Milford

STREET AND VILLAGE, OR SECTION AND TOWNSHIP

County of Oakland, State of Michigan, and described as follows:

All that part of the Southeast 1/4 of the Northeast 1/4 of Section 6, Town 2 North, Range 7 East, lying Northerly of West Commerce Road.

The route of the lines shall be as follows: In a Northwesterly direction from a point on the centerline of Hickory Ridge Road, 190 feet North of the centerline of Commerce Road to a point on the above described property 330 feet North of the centerline of Commerce Road and 134 feet West of the centerline of Hickory Ridge Road, thence West for a distance of 370 feet to a point being 150 Northeast of centerline of Commerce Road.

The Company, its successors and assigns, shall reimburse us for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property from time to time for the purposes set forth herein.
