IN CONSIDERATION of the sum of One and no/100 (\$1.00) - - - - Dollars and other valuable considerations,

receipt of which is hereby acknowledged WE hereby grant to **THE DETROIT EDISON COMPANY**, its successors and assigns, the right to construct, operate and maintain its underground lines for the transmission and distribution of electricity and Company communication facilities, including the necessary conduits, fixtures, cables, manholes and equipment, under and across OUR property located in City of Walled Lake, County of Oakland State of Michigan, and described as follows:

Part of Lot 46 of Supervisors Plat No. 4 being part of the West 1/2 of Section 26; part of the Southeast 1/4 of Southeast 1/4 of Section 27; part of Northeast 1/4 of Section 34 and part of the Northwest 1/4 of Section 35, T 2 N, R 8 E as recorded in Liber 54A on Page 79A of Oakland County Records, described as beginning at the intersection of the Northwest corner of Lot 47 of above named Subdivision and the East line of Pontiac Trail (83 feet wide); thence in a North-easterly direction on the East side of Pontiac Trail 20 feet more or less to a point; thence in an Easterly direction parallel to the North line of said Lot 46, 200 feet; thence Southerly at right angles to said line, 20 feet to a point; thence Westerly to the point of beginning.

The route of the lines shall be as follows:

In a northeasterly and southwesterly direction across and under said land along and adjacent to the southerly line thereof. Approx 100ft in length

The Company shall reimburse US for all damage caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purposes set forth herein.
