OVERHEAD EASEMENT (RIGHT OF WAY) NO. 0-1244

"Grantor's Land" is in the City of Wixom, Oakland County, Michigan described as:

All of lot 11 and the westerly 26.37 feet of Lot 12. Beck-Tec Industrial Park as recorded in Liber 202, Pages 1 and 2 of Plats, Oakland County Records. Sidwell No: 22-08-227-020 70700

The "Right of Way Area" is a part of Grantor's Land described as:

The westerly 10 feet of the easterly 37 feet of the southerly 65 feet.

- 1. Purpose: The purpose of this Right of Way is to construct, reconstruct, modify, add to, operate and maintain overhead utility line facilities consisting of poles, guys, anchors, wires, cables, transformers and accessories.
- 2. Access: Grantee has the right of access to and from the Right of Way Area.
- 3. Buildings or other Permanent Structures: No buildings or other permanent structures shall be placed in the Right of Way Area without Grantee's prior written consent.
- 4. Trees, Bushes, Branches or Roots: Grantee may trim, cut down, remove or otherwise control any trees, bushes, branches or roots in the Right of Way Area (or that could grow into the Right of Way Area) that Grantee believes could interfere with the safe and reliable construction, operation and maintenance of Grantee's facilities.
- 5. Restoration: If Grantee's employees, contractors, vehicles or equipment damage Grantor's Land while entering Grantor's Land for the purposes stated in this Right of Way, then Grantee shall restore Grantor's Land as nearly as can be to its original condition.

6. Successors: This Right of Way runs with the land and binds and benefits Grantor's and Grantee's successors, lessees, licensees and assigns.
