IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, we hereby grant to THE DETROIT EDISON COMPANY its successors and assigns, the right to construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary towers, fixtures, wires and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their operation upon, over and across our property located in CITY OF PONTIAC

County of OAKLAND, State of Michigan, and described as follows:  
Lots 16, 17, 45, 46 and 75 of Chief Pontiac Farms, a subdivision of part of the Southwest Quarter of Section 10, T 3 N, R 10 E.

The route of the lines shall be as follows: Along East of and adjacent to the West lot lines of Lots 16, 46 and 75 and along West of and adjacent to the East lot lines of Lots 17 and 45 above described.

The Company, its successors and assigns, shall reimburse US for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purposes set forth herein.

In addition to the above consideration, the Company, or its successors and assigns, shall pay US the sum of Seven hundred & 50/100 (750.00) Dollars for above right-of-way on said land, the same to be paid before any towers are erected.
