IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, We hereby grant to THE DETROIT EDISON COMPANY, its successors and assigns, the right to construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary poles, fixtures, guys and guy stubs, wires and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their

operation upon, over and across our property located in the City of Pontiac
STREET AND VILLAGE OR SECTION AND TOWNSHIP

County of Oakland State of Michigan, and described as follows:

Part of the S.E. 1/4 of the S.E. 1/4 of Sec 7 T3N, R10E described as being bounded on the N+E by Pontiac Telegraph Rd.

Subd. on the South by Center Line of Walton Blvd on the West by Centerline of Newark St. except a parcel of land in SW Cor, 120 ft E+W by 135 ft N+S

the route of the lines shall be as follows: Installed anchor guys in an easterly and westerly direction from pole on Newark, approx 202 ft north of Walton Blvd.

The Company shall reimburse us for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purpose set forth herein.

In addition to the above consideration, the Company shall pay us the sum of Ten (\$10.00) and no/100 Dollars for anchors on said land, the same to be paid before any work is done

When 60 days written notice, the Company shall make such changes and alterations in said lines as shall be necessary at the time to avoid interference with any improvements or buildings a course of objection on said property
