WE IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, WE hereby grant to THE DETROIT EDISON COMPANY, its successors and assigns, the right to overhang only construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary poles, towers, guys and guy wires, wires, and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their operation upon, over and across OUT property located in VILLAGE OF Rochester STREET AND VILLAGE OR SECTION AND TOWNSHIP

County of CHLIND State of Michigan, and described as follows:
THE NORTH 6 FT ~~AND THE EAST 1/2 OF THE NORTH 1/2 OF~~ LOT 12 OF "SUPERVISOR'S PLAT #2, A REPLAT OF LOTS 134 TO 149 INC. OF RICHARDSON-ADAMS ADDITION, ALSO PART OF THE WEST 1/2 OF SECTION 14 TOWN 3 NORTH RANGE 11 EAST AS RECORDED IN LIBER 5411 PAGE 92 OF OAKLAND COUNTY RECORDS

The route of the lines shall be as follows: IN AN EASTERLY AND SOUTHWESTLY DIRECTION, ALONG AND ADJACENT TO THE NORTH LINE OF PLOT

The Company shall reimburse me for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purpose set forth herein.

In addition to the above consideration, the Company shall pay me the sum of FIVE 4/100 (\$5.00) Dollars for above on said land, the same to be paid before any poles are erected.

If necessary to cut trees, permission is granted, providing, reasonable compensation is paid.
