STREET AND VILLAGE, OR SECTION AND TOWNSHIP

County of OAKLAND, State of Michigan, and described as follows:
THE SOUTHWEST 30 FT OF LOT 14 OF THE HOWARD AND HAMMOND ADDITION TO THE VILLAGE OF ROCHESTER, PART OF THE SE 1/4 OF SECTION 10 T3N R1E AS RECEIVED IN LIBER 10 ON PAGE 6 OF OAKLAND COUNTY RECORDS, ALSO THE SOUTHWEST 13 FT (OVER)

The route of the lines shall be as follows: IN A NORTHWESTERLY AND SOUTHEASTERLY DIRECTION, FROM A POINT ON THE SOUTH LINE APPROX 9 FT NORTHEAST OF THE SOUTHWESTERLY LINE, TO A POINT ON THE NORTH LINE, APPROX 5 FT NORTHEAST OF THE SOUTHWESTERLY LINE.

The Company, its successors and assigns, shall reimburse NO for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property from time to time for the purposes set forth herein.
