Agreement, Made and entered into this 12th day of June 2145

A. D., 1912., by and between A.E. Williams

Rochester Oakland County, Michigan, first party, and EASTERN MICHIGAN EDISON COMPANY, a Corporation, second party

WITNESSETH:

In consideration of the sum of One (\$1.00) dollar, receipt of which is hereby acknowledged, first party, for himself, his heirs, executors, administrators and assigns, hereby grants unto said second party, its successors and assigns, the right, privilege and authority to construct, operate, and maintain, during the corporate existence of said second party, its lines for electric light and power, including the necessary poles, towers, wires, and fixtures upon, over, and across the property which he own, or in which he has an interest, in the Village of Rochester County of Oakland, and State of Michigan, the route of said line being as follows:

X Directly across Mr. William's property, running north and south from Baldwin Street continued to the Disco Road *X*

Second party shall have the right to permit the attachment of the wires of any other company, and shall have the right to trim any trees along said lines so as to keep the wires clear at least Four (4) feet, ~~to erect and set the necessary poles and lines~~ poles and anchors and to attach thereto the necessary wires; and second party shall also have the right to further extend its said lines across said lands for the purpose of enabling it to furnish service to the owners or occupants of property beyond, the location of said further poles, wires and lines to be such as not to interfere with the erection of any buildings on said lands.

Second party agrees to reimburse said first party, his heirs and assigns, for all damages to his growing crops, caused by its men and teams in entering said property from time to time for the purposes set forth herein.
