Agreement,

Made and entered into this 6th day of June

A. D., 1912, by and between The Western Knitting Mills Company, of Rochester,
Oakland County, Michigan, first party, and EASTERN MICHIGAN EDISON
COMPANY, a Corporation, second party.

WITNESSETH:

In consideration of the sum of One (\$1.00) dollar, receipt of which is hereby acknowledged, first party, for itself, its heirs, executors, administrators and assigns, hereby grants unto said second party, its successors and assigns, the right, privilege and authority to construct, operate, and maintain, during the corporate existence of said second party, its lines for electric light and power, including the necessary poles, towers, wires, and fixtures upon, over, and across the property which it own, or in which it has an interest, in the Village of Rochester

County of Oakland, and State of Michigan, the route of said line being as follows: Through parcels #10, 11, and 12 on the west side of Baldwin Street continued and east of Chapman's Lake.

Second party shall have the right to permit the attachment of the wires of any other company, and shall have the right to trim any trees along said lines so as to keep the wires clear at least Four (4) feet, to erect and set the necessary guy and brace poles and anchors, and to attach thereto the necessary guy wires; and second party shall also have the right to further extend its said lines across said lands for the purpose of enabling it to furnish service to the owners or occupants of property beyond, the location of said further poles, wires and lines to be such as not to interfere with the erection of any buildings on said lands.

Second party agrees to reimburse said first party, its heirs and assigns, for all damages to its growing crops, caused by its men and teams in entering said property from time to time for the purposes set forth herein.

IN WITNESS WHEREOF first party has hereunto set its hand and seal, and second party has caused these presents to be executed the day and year first above written.
