Agreement, Made and entered into this 11th day of October

A.D. 1916, by and between H.H. Mack and Lida Mack his wife

of Oakland County, Michigan, first parties, and THE DETROIT EDISON COMPANY, a Corporation, second party.

WITNESSETH:

In consideration of the sum of One (\$1.00) dollar, receipt of which is hereby acknowledged, first parties, for them, their heirs, executors, administrators and assigns, hereby grants unto said second party, its successors and assigns, the right, privilege and authority to construct, operate, and maintain, during the corporate existence of said second party, its lines for electric light and power, including the necessary poles, towers, wires, and fixtures upon, over, and across the property which they own, or in which they have an interest, in the Village of Rochester, County of Oakland, and

State of Michigan, the route of said line being as follows: About due east and west within three(3) feet of south line of that part of the east half of the southwest quarter of section eleven town three north range eleven east Michigan meridian described as beginning at the south quarter part on said section eleven and thence north along the north and south quarter line eight chains and ninety nine links thence west ten chains and sixty eight and one half links thence south nine chains thirty six and one half links to the south line of said section thence east ten chains sixty three and one half links to place of beginning.

Second party shall have the right to permit the attachment of the wires of any other company, and shall have the right to trim any trees along said lines so as to keep the wires clear at least Four (4) feet, to erect and set the necessary guy and brace poles and anchors, and to attach thereto the necessary guy wires.

Second party agrees to reimburse said first parties, their heirs and assigns, for all damages to their growing crops, buildings or fences, caused by its men and teams in entering said property from time to time for the purposes set forth herein.

IN WITNESS WHEREOF first parties have herunto set their hand and seal, and second party has caused these presents to be executed the day and year first above written.
