PARTIAL ASSIGNMENT OF EASEMENT RIGHTS

The Detroit Edison Company, a Michigan corporation of One Energy Plaza, Detroit, Michigan 48226 ("EDISON"), for good and valuable consideration hereby conveys, assigns and quitclaims to International Transmission Company, a Michigan corporation of 27175 Energy Way, Novi, Michigan 48377 ("ITC"), its successors and assigns, forever, certain easement rights on property located in the SW ¼ of Section 3, City of Rochester Hills, Oakland County, Michigan, which easement rights were reserved to EDISON pursuant to a QUIT CLAIM DEED dated September 19, 1990 from EDISON to THE CITY OF ROCHESTER HILLS, a Michigan municipal corporation, which QUIT CLAIM DEED was recorded in Liber 11779, Page 575, Oakland County Register of Deeds.

It is understood that the above-referenced easement rights are for the right of EDISON to construct and maintain its lines, cables and related facilities on lands located in Oakland County, Michigan, including a road easement and including the right to clear and keep the lands clear of trees, upon, over and across said lands described as follows:

Land located in the City of Rochester Hills, Oakland County, State of Michigan:

Part of the Southwest 1/4 of Section 3, Town 3 North, Range 11 East, further described as: Beginning at a point on the South Line of Section 3 (also being the centerline of Tienken Road), distant North 89°25'15" East, 390.53 feet from the Southwest corner of said Section 3; thence North 00°39'45" West, 60.00 feet; thence North 89°25'15" East, 358.92 feet; thence South 00°51'45" East, 60.00 feet; thence South 89°25'15" West, 359.13 feet along the South line of said Section 3 to the point of beginning. Containing 0.495 acres or 21,541 square feet of land.

It is also understood that the above-referenced easement may at some time accommodate both transmission facilities (120 kV or higher) and distribution facilities (less than 120 kV). EDISON reserves unto itself, its successors and any future assignees, those easement rights relating to such distribution facilities including all tree trimming and vegetation management rights, if any. Therefore, this assignment shall only assign the easement rights relating to the transmission facilities and ITC takes subject to the right of EDISON to utilize these easements for distribution and related purposes, including tree trimming and vegetation management purposes, if any.

EDISON covenants and agrees that (1) EDISON has the lawful right to transfer said easement rights, and (2) EDISON has not, through its own act or omission, impaired the transferability of said easement rights.
