



Cheryl, Southwest Region Distribution Planning can release the Edison pole line easement on the condition that we retain the right to maintain an existing pole lead on the north end of the subject property. The easement is recorded in Liber 2717, Page 411. Release of the easement was requested by Donald Frericks.

It is not clear from the information provided whether the existing overhead lead makes use of the easement or not. The lead is serving customers that are on properties that run east and west along the south side of White Lake Road. From information on Fieldview and Property Description Maps for Oakland County, the lead appears to be on the property it serves and not on the property owned by Mr. Frericks. If that is the case then the easement can be released. If the lead is on the Frericks' property then it must be maintained to serve the customers described above.
