IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, We hereby grant to THE DETROIT EDISON COMPANY, its successors and assigns, the right to construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary poles, fixtures, guys and guy stubs, wires and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their operation upon, over and across our property located in Highland Township

County of Oakland State of Michigan, and described as follows:

That part of the NW 1/4 of the SE 1/4 of Sec. 2, T3N, R7E, described as beginning at the center of Section 2; thence North 89° 54' E. 608.34 feet along the E. and W. 1/4 line to the point of beginning of this description; thence South 0° 25' 30" West 1326.82 ft.; thence South 89° 09' 30" East 157.48 ft. to the White Lake Road; thence Northeasterly along said road 90.13 ft. thence North 0° 25' 30" West 1322.58 ft. to East and West 1/4 line, thence North 89° 54' West 235.35 ft. to point of beginning except a parcel 90 by 100' in the SW corner thereof.

The route of the lines shall be as follows: In a northeasterly and southwesterly direction across said land along approximately 230 feet North of and parallel to highway known as White Lake Road.

The Company shall reimburse US for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purpose set forth herein.

In addition to the above consideration, the Company shall pay US the sum of Five and no/100 (\$5.00) Dollars each pole on said land, the same to be paid before any poles are erected.
