IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, we hereby grant to THE DETROIT EDISON COMPANY, its successors and assigns, the right to construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary poles, fixtures, guys and guy stubs, wires and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their

operation upon, over and across our property located in Township of Highland  
STREET AND VILLAGE OR SECTION AND TOWNSHIP

County of Oakland State of Michigan, and described as follows:

A parcel of land of 1 acre ±, described as that part of the E 1/2 of SW 1/4 beginning at SW cor. of E 1/2 of SW 1/4, thence E 241 ft to N line of P.M. RR (now C+O RR) Right of Way, thence N along SD line 180.75 ft thence N 241 ft, thence S 180.75 ft to point of beginning in T 37, R 07 E, Sec 10, Highland Township, Oakland Co  
The route of the lines shall be as follows:

Across above described land parallel to and 5 ft west of the C+O RR Right of Way

The Company shall reimburse us for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purpose set forth herein.

In addition to the above consideration, the Company shall pay Five + 20/100 (\$5.00) Dollars for each pole on said land, the same to be paid before any poles are erected.
