We are enclosing herewith a Pole Line Permit dated April 27, 1959, wherein Eli J. Stanley and Sabina M. Stanley, his wife, grant to The Detroit Edison Company a right of way across Lot 23 of Highland Country Club Subdivision, Highland Township, Oakland County, Michigan

This permit was procured in connection with a settlement of a claim for damages which arose out of the non-permissive cutting of a tree on the Stanley property on November 4, 1958.

It is our understanding that the pole line presently crosses this property, but it was deemed advisable to procure the right of way in view of our experience with the Stanleys.

Under the circumstances, it is recommended that this permit be recorded.
