### **OVERHEAD EASEMENT (RIGHT OF WAY) NO. 0-1265**

## $\mathcal{C}^{OV}$ The "Right of Way Area" is a part of Grantor's Land described as:

Permission to extend wires in an easterly and westerly direction across said land and install a pole with anchor at the easterly property line as shown on Detroit Edison Company drawing O-1265 date 5/3/91 which is attached hereto and made a part hereof. The right of way is ten (10) feet in width.

1. Purpose: The purpose of this Right of Way is to construct, reconstruct, modify, add to, operate and maintain overhead utility line facilities consisting of poles, guys, anchors, wires, cables, transformers and accessories.

2. Access: Grantee has the right of access to and from the Right of Way Area.

3. Buildings or other Permanent Structures: No buildings or other permanent structures shall be placed in the Right of Way Area without Grantee's prior written consent.

4. Trees, Bushes, Branches or Roots: Grantee may trim, cut down, remove or otherwise control any trees, bushes, branches or roots in the Right of Way Area (or that could grow into the Right of Way Area) that Grantee believes could interfere with the safe and reliable construction, operation and maintenance of Grantee's facilities.

5. Restoration: If Grantee's employees, contractors, vehicles or equipment damage Grantor's Land while entering Grantor's Land for the purposes stated in this Right of Way, then Grantee shall restore Grantor's Land as nearly as can be to its original condition.

6. Successors: This Right of Way runs with the land and binds and benefits Granton's and Granton's and Granton's frequences, licensees and assigns.
