## OVERHEAD EASEMENT (RIGHT OF WAY) NO. 0-1519 R1

"Grantor's Land" is in Township of Highland, Oakland County, described as: T3N, R7E, Section 5, north 20 acres of NW Frc 1/4 of TW Frc 1/4. 20 Acres. Sidwell No. 11-05-100-001.

The "Right of Way Area" is a part of Grantor's Land and is described as:

The easterly 10 ft., of the westerly 63 ft. The right of way is ten (10) feet in width.

1. Purpose: The purpose of this Right of Way is to construct, reconstruct, modify, add to persite and maintain overhead utility line facilities consisting of poles, guys, anchors, wires, cables, transformers and accessor signal and access

2. Access: Grantee has the right of access to and from the Right of Way Area.

3. Buildings or other Permanent Structures: No buildings or other permanent structures shall be placed in the Right of Way Area without Grantee's prior written consent.

4. Trees, Bushes, Branches or Roots: Grantee may trim, cut down, remove or otherwise control any trees, bushes, branches or roots in the Right of Way Area (or that could grow into the Right of Way Area) that Grantee believes could interfere with the safe and reliable construction, operation and maintenance of Grantee's facilities. ALCORDED RIGHT

5. Restoration: If Grantee's employees, contractors, vehicles or equipment damage Grantor's Land while entering Grantor's Land for the purposes stated in this Right of Way, then Grantee shall restore Grantor's Land as nearly as can be to its original condition.

6. Successors: This Right of Way runs with the land and binds and benefits Grantor's and Grantee's successors, lessees. licensees and assigns.
