

For good and valuable considerations, the right is hereby granted to THE DETROIT EDISON COMPANY, 2000 Second Ave. Detroit, Michigan, their licensees, lessees, successors and assigns, to construct aerial line facilities for the purpose of providing electric service and communication service including necessary poles, guys, anchors, conduits, wires, cables, manholes, transformers and equipment in, under, upon, over and across the property located in the village of

Lake Orion, County of Oakland, State of Michigan, further described as follows:

The East 12 feet of the West 29 feet of the following described property:

Part of the northeast 1/4, Section 11, Town 4 North, Range 10 East, Lot 57,

The route of overhead line facilities is described as follows:

In a northerly and southerly direction across said land, along a line approximately 52 feet East of and parallel to the centerline of Lapeer Road (M-24).

Underground lines are to be located in accordance with attached drawings which are hereby made a part of and incorporated into this grant.

This grant is hereby binding upon the heirs, successors and assigns of the undersigned grantors.
