

UNDERGROUND EASEMENT (RIGHT OF WAY) NO. 0-1544

On 3/26/92, 1992, for the consideration of system betterment, Grantor grants to Grantee a permanent underground easement ("Right of Way") in, on and across a part of Grantor's Land called the "Right of Way Area".

"Grantor's Land" is in the Village of Ortonville, Oakland County, Michigan, described as:

Parcel "G" T5N, R9E, Sec 8, Part of SW 1/4 Beg at Pt Dist S 00°06'32" W 840 Ft from W 1/4 Cor, Th S 00°06'32" W 130 Ft, Th S 89°57'02" E 166.20 Ft, Th N 00°06'32" E 150 Ft, Th S 83°11'19" W 167.42 Ft to Beg. 0.53 Acres - Sidwell No: 03-08-301-026.

The "Right of Way Area" is a part of Grantor's Land and is described as:

A 12 Ft wide easement lying West of and Adjacent to the private road as shown on the attached DECO Drawing #0-1544 dated March 24, 1992 and also the E 6 Ft of the S 78 Ft of the above described property.

- 1. Purpose: The purpose of this Right of Way is to construct, reconstruct, modify, add to, operate and maintain underground utility line facilities consisting of poles, guys, anchors, wires, manholes, conduits, pipes, cables, transformers and accessories.
2. Access: Grantee has the right of access to and from the Right of Way Area.
3. Buildings or other Permanent Structures: No buildings or other permanent structures shall be placed in the Right of Way Area without Grantee's prior written consent.
4. Excavation: As required by Public Act 53 of 1974, MISS DIG must be called on 1-800-482-7171 before anyone excavates in the Right of Way Area.
5. Trees, Bushes, Branches, Roots, Structures and Fences: Grantee may trim, cut down, remove or otherwise control any trees, bushes, branches and roots in the Right of Way Area (or that could grow into the Right of Way Area) and remove structures and fences in the Right of Way Area that Grantee believes could interfere with the safe and reliable construction, operation and maintenance of Grantee's facilities.
6. Restoration: If Grantee's employees, contractors, vehicles or equipment damage Grantor's Land while entering Grantor's Land for the purposes stated in this Right of Way, then Grantee shall restore Grantor's Land as nearly as can be to its original condition.
7. Successors: This Right of Way runs with the land and binds and benefits Grantor's and Grantee's successors, lessees, licensees and assigns.
