

PARTIAL RELEASE OF RIGHT OF WAY

THIS INDENTURE made this 21st day of July, 1969, between THE DETROIT EDISON COMPANY, a corporation organized and existing concurrently under the laws of the states of Michigan and New York, with principal offices at 2000 Second Avenue, Detroit, Michigan 48226, hereinafter referred to as "EDISON," and ORVAL A. OPPERTHAUSER and RUTH E. OPPERTHAUSER, his wife of 5425 Bywood, Bloomfield Hills, Michigan hereinafter referred to as "OWNER."

W I T N E S S E T H:

WHEREAS on August 2, 1929, Rachel A. Misener, et al, granted to EDISON a right of way for the purpose of constructing, operating and maintaining its lines and equipment for the transmission and distribution of electricity over and across premises in the Township of Brandon, County of Oakland, State of Michigan, described as follows:

The east 1/2 of the southwest 1/4 and the north 1/2 of the southeast 1/4 all in Section 15, Township 5 North, Range 9 East

which right of way is recorded in Liber 25, Miscellaneous Records, Page 257, Oakland County Records, and

WHEREAS, OWNER has acquired a fee interest in a portion of the above described property described as:

The east 1/2 of the southwest 1/4 of Section 15, Township 5 North, Range 9 East, Brandon Township, Oakland County, Michigan and

OWNER has requested that EDISON release that portion of the premises last described from the encumbrance of said Right of Way Grant dated August 2, 1929 and EDISON is willing to do so.

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other valuable considerations, the receipt of which is hereby acknowledged EDISON does, by these presents, expressly release and abandon unto OWNER their successors and assigns, all of the rights acquired by it by virtue of the aforementioned right of way over said premises last described above. In all other respects, except as partially released herein, said Right of Way Grant dated August 2, 1929, shall remain in full force and effect.
