Forever, the easement and right to enter at any time and from time to time upon land hereinafter described and to cut, trim, remove, destroy, or otherwise control any or all trees and brush now or hereafter standing or growing on said land, said land being in the Township of West Branch, County of Ogemaw, and State of Michigan, described as:

The East 40 feet of the Northerly 544 feet of the Southerly 604 feet of the Southeast 1/4 of the Southwest 1/4 of Section 24, Township 22 North, Range 2 East.

It is expressly agreed that nonuse or a limited use of the easement and rights hereby granted shall not prevent Grantee from later making use of said easement and rights to the full extent herein authorized. It is further agreed that the consideration received by Grantor for this easement shall be in full payment for the easement and rights hereby granted and for all trees and brush now or hereafter standing or growing on said land.
