This Indenture, made December 22, 1967 BETWEEN

STEVE B. SECHKAR and LENA MAE SECHKAR, his wife, of 4213 West 20th Street, Cleveland, Ohio, parties of the first part, and CONSUMERS POWER COMPANY, a corporation duly authorized to do business in Michigan and having its principal office therein at 212 West Michigan Avenue, Jackson, Michigan 49201, party of the second part.

Witnesseth, That the said party of the first part, for and in consideration of the sum of ONE DOLLAR and Other Good and Valuable Consideration to him in hand paid by the said party of the second part, the receipt whereof is hereby confessed and acknowledged, does by these presents grant, bargain, sell, remise, release, alien and confirm unto the said party of the second part, its successors and assigns, Forever, all that certain piece or parcel of land situate and being in the Township of Chester, County of Otsego and State of Michigan, and described as follows, to-wit:

A 365 foot strip of land across the N 1/2 of the S 1/2 of the NW 1/4 of the SW 1/4 of Section 12, T29N, R2W, described as follows: To find the place of beginning of this description commence at the W 1/4 post of said section; run thence S 89° 29' 57" E along the East and West 1/4 line of said section 684.57 feet; thence S 27° 14' 03" E, 744 feet to the North line of the N 1/2 of the S 1/2 of the NW 1/4 of the SW 1/4 of said section and the place of beginning of this description; thence continuing S 27° 14' 03" E, 371.48 feet to the South line of the N 1/2 of the S 1/2 of the NW 1/4 of the SW 1/4 of said section; thence N 89° 39' 16" W along the South line of the N 1/2 of the S 1/2 of the NW 1/4 of the SW 1/4 of said section 411.79 feet; thence N 27° 14' 03" W, 371.9 feet to the North line of the N 1/2 of the S 1/2 of the NW 1/4 of the SW 1/4 of said section; thence S 89° 36' 10" E, 411.99 feet along the North line of the N 1/2 of the S 1/2 of the NW 1/4 of the SW 1/4 of said section 411.99 feet to the place of beginning.

And the said party of the first part, for himself, his heirs, executors and administrators, does covenant, grant, bargain and agree to and with the said party of the second part, its successors and assigns, that at the time of the delivery of these presents he is well seized of the above granted premises in fee simple; that they are free from all incumbrances whatever and that he will, and his heirs, executors, and administrators shall Warrant and Defend the same against all lawful claims whatsoever.

NOTE #3 contd: The 2 gas pipelines to be located within each of the 10 foot wide strips of 1d desc above as Pcls "A", "B" & "C" shall be buried in parallel with each other in a single trench and shall run parallel to the above desc cen ln of the particular Pcl as nearly as practicable. Each of sd gas pipelines shall be buried not less than 3 ft below the surface of the ground sd distance being measured vertically from the surface of the ground to the top of the gas pipelines.
