Witnesseth, That the said party of the first part, for and in consideration of the sum of TEN THOUSAND AND NO/100 Dollars (\$10,000.00) to him in hand paid by the said party of the second part, the receipt whereof is hereby confessed and acknowledged, does by these presents grant, bargain, sell, remise, release, alien and confirm unto the said party of the second part, its successors and assigns, Forever, all that certain piece or parcel of land situate and being in the Township of Chester, County of Otsego and State of Michigan, and described as follows, to-wit:

Parcel 1: A strip of land 330 feet wide in a part of the S 1/2 of the NE 1/4 of Section 11, T29N, R2W, described as follows: To find the place of beginning of this description commence at the E 1/4 post of said section; run thence N 00° 09' 35" E along East line of sd sec 136.65 feet to place of beginning of this description; thence continuing along sd East line of sd sec N 00° 09' 35" E, 346.28 feet; thence N 72° 12' 07" W, 344.76 feet; thence S 00° 11' 04" W, 346.23 feet; thence S 72° 12' 07" E, 344.91 feet to place of beginning.

Parcel 2: A parcel of land in the SW 1/4 of the NW 1/4 of Section 12, T29N, R2W, described as follows: To find the place of beginning of this description commence at the W 1/4 post of said section; run thence N 00° 09' 35" E along West line of sd sec 136.65 feet to place of beginning of this description; thence continuing along said West line of sd sec N 00° 09' 35" E, 346.28 feet; thence S 72° 12' 07" E, 542.96 feet; thence S 27° 14' 03" E, 363.21 feet to the East and West 1/4 line of sd sec; thence N 89° 29' 57" W along said East and West 1/4 line of sd sec 412.38 feet; thence N 27° 14' 03" W, 69.76 feet; thence N 72° 12' 07" W, 251.93 feet to place of beginning.

Also excepting and reserving to first party herein, his heirs or assigns, all oil, gas and other minerals (but not including sand, clay or gravel) in and under said Parcels 1 and 2, together with the right to remove the same by wells or shafts placed on the adjoining land. No wells or shafts are to be placed on the land herein conveyed.

Together with all and singular the hereditaments and appurtenances thereunto belonging or in anywise appertaining: To Have and to Hold the said premises, as herein described, with the appurtenances, unto the said party of the second part and to its successors and assigns, Forever. And the said party of the first part, for himself, his heirs, executors and administrators, does covenant, grant, bargain and agree to and with the said party of the second part, its successors and assigns, that at the time of the delivery of these presents he is well seized of the above granted premises in fee simple; that they are free from all incumbrances whatever and that he will, and his heirs, executors, and administrators shall Warrant and Defend the same against all lawful claims whatsoever.

Each of sd gas pipelines shall be buried not less than 3 ft below the surface of the ground, sd distance being measured vertically from the surface of the ground to the top of the gas pipelines.
