party of the second part.

Witnesseth, That the said party of the first part, for and in consideration of the sum of  
Thirteen Thousand and no/100

Dollars (\$13,000.00) to him in hand paid by the said party of the second part, the receipt whereof  
is hereby confessed and acknowledged, does by these presents grant, bargain, sell, remise, release, alien and confirm  
unto the said party of the second part, its successors and assigns, Forever, all that certain piece or parcel of land situate  
and being in the Township of Chester County of Otsego and State of  
Michigan, and described as follows, to-wit:

A 330 foot strip of land across the W 7/8 of the S 1/2 of the  
NE 1/4 of Section 11, T29N, R2W, described as follows: To find  
the place of beginning of this description, commence at the E 1/4  
post of said section; run thence N 00° 09' 35" E along the East  
line of said section 482.5 feet; thence N 72° 11' 38" W 344.77  
feet to the East line of the W 7/8 of the S 1/2 of the NE 1/4 of  
said section and the place of beginning of this description;  
thence continuing N 72° 11' 38" W 2410.75 feet to the place of  
intersection of the North 1/8 line of said section with the North  
and South 1/4 line of said section; thence S 00° 21' 27" W along  
the said North and South 1/4 line of said section 345.05 feet;  
thence S 72° 11' 38" E 2411.59 feet to the said East line of the  
W 7/8 of the S 1/2 of the NE 1/4 of said section; thence N 00° 11'  
01" E along the said East line of the W 7/8 of the S 1/2 of the  
NE 1/4 of said section 345.38 feet to the place of beginning.

Excepting and reserving to first party, his heirs or assigns,  
the easement and right to cross said strip of land at such places  
and in such a manner as is mutually satisfactory to both parties  
so long as said crossing shall not interfere with the use of  
said land by second party, its successors or assigns.

Also excepting and reserving to first party herein, his heirs  
or assigns, all oil, gas and other minerals (but not including  
sand, clay or gravel) in and under said land, together with the  
right to remove the same by wells or shafts placed on the  
adjoining land. No wells or shafts are to be placed on the  
land herein conveyed.

It is understood and agreed that second party will, at its  
sole cost and expense, erect gates in the fences along said  
above-described strip of land to provide second party's ingress  
to and egress from the same.

The esmt and right to construct, maintain, repair and replace 2 gas pipelines, not larger than 6 inch diameter each, under and across each of the following desc pcls of ld situate in the Twp of Chester, Co of Otsego and State of Mich:

PCL "C": A part of the SW 1/4 of the NE 1/4 of Sec 11, T29N, R2W, more fully desc as follows: A strip of ld 10 ft in width, lying 5 ft on each side of a cen ln desc as follows: To find the POB of sd cen ln of sd 10 foot wide strip of ld, comm at the E 1/4 cor of sd Sec 11; th N 00 deg 09' 35" E, alg the E ln of sd sec, 136.65 ft to the SW'ly boundary ln of CPCo property; th N 72 deg 12' 07" W, alg sd SW'ly ln; 2599.41 ft to a ln which is 150 ft E of and parallel to the N & S 1/2 ln of sd sec, and the POB of sd cen ln of the herein desc 10 foot wide strip of ld; th N 00 deg 21' 27" E, parallel to sd N & S 1/2 ln, 345.90 ft to the NE'ly boundary ln of CPCo property, and the POE of sd cen ln of the herein desc 10 foot wide strip of ld.
