Witnesseth, That the said party of the first part, for and in consideration of the sum of ONE DOLLAR and Other Good and Valuable Consideration to him in hand paid by the said party of the second part, the receipt whereof is hereby confessed and acknowledged, does by these presents grant, bargain, sell, remise, release, alien and confirm unto the said party of the second part, its successors and assigns, Forever, all that certain piece or parcel of land situate and being in the Township of Hayes, County of Otsego and State of Michigan, and described as follows, to-wit:

18 A triangular parcel of land in the SW 1/4 of the SE 1/4 of Section 9, T30N, R4W, described as follows: To find the place of beginning of this description commence at the Southeast corner of said section; run thence S 88° 30' 10" W along the South line of said section 1377.02 feet to the East 1/8 line of said section and the place of beginning of this description; thence continuing S 88° 30' 10" W along said South line of said section 100.15 feet; thence N 46° 03' 20" E, 137.7 feet to the East 1/8 line of said section; thence S 00° 35' 45" E along the East 1/8 line of said section 92.95 feet to the place of beginning.

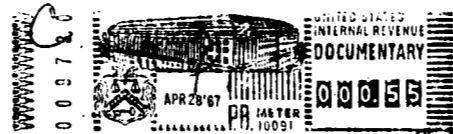
