East of the West line of sd. Sec. run. th. Northwest to a pt. not more than 4 feet West of the East line of Section 29 of sd. Township at a pt. not more than 550 ft. North of the East and West 1/4 line of sd. Sec. 29, th. Northerly and not more than 4 ft. West of the East line of sd. Sec. 29 to a point not more than 1050 feet North of the East and West 1/4 line of sd. Sec. 29 to a pt. not more than 800 ft. nor less than 600 ft. West of the North and South 1/4 line of Sec. 21 of sd. Township, at a pt. not more than 800 ft., nor less than 600 ft. North of the South line of sd. Sec. 21.

Second party is to pay for any damage to crops caused by the erecting or maintaining of said line of wires.
