County of Otsego, a municipal corporation, by its duly authorized officers first part y, in consideration of One Dollar (\$1.00) to it paid by the CONSUMERS POWER COMPANY...

All that part of the South one-half (1/2) of the Southwest one-quarter (1/4) of Section 32, Township thirty-one (31) North, Range three (3) West, Lying Southerly of the former Boyne City - Gaylord and Alpena Railroad right of way.

The route to be taken by said lines of wires, poles, wires, cables and conduits across, over and under said land being more specifically described as follows:

Second party may locate said route in an Easterly and Westerly direction on over and across said above-described land, Northerly of and not more than 1000 feet nor less than 800 feet from the South line of Section 32.

With full right and authority to the second party, its successors, licensees, lessees or assigns, and its and their agents and employees, to enter at all times upon said premises for the purpose of constructing, repairing, removing, replacing, improving, enlarging and maintaining such cables, conduits and wires, poles and other supports...

Second party to pay at the rate of Eighty Dollars (\$80.00) per mile of length of the line of poles and wires across said above-described premises, the same to be paid before any work is done on the land, and also to pay for any damage to crops in erecting and maintaining said line of poles and wires.
