The route to be taken by said lines of towers, poles, wires, cables and conduits across, over and under said land being more specifically described as follows:

The center line of said route being Northerly of and along and not more than 1665 ft. nor less than 1565 ft. from the South line of Section 31, Township 31 North, Range 3 West.

Together with the full right and authority to Grantee, its successors, licensees, lessees or assigns, and its and their agents and employees, to enter at all times upon said premises for the purpose of constructing, repairing, removing, replacing, patrolling, improving, enlarging and maintaining such cables and conduits and such towers, poles and other supports...

Second party to pay first party for any damage to crops in erecting and maintaining said line of towers, poles and wires.
